A new report suggests that significant education achievement gaps present across the country exist due to the increasing frequency of chronic absenteeism, especially among low-income and minority students.

While school districts typically focus on students who skip school, the report, put together by nonprofits Attendance Works and the Healthy Schools Campaign, argue that absenteeism rates among kindergartners are almost as high as among high school freshmen. According to the report, 1 in 10 kindergarten students misses about 18 days of school – almost an entire month – each year.

Title IX Update: My Summer Experience with Pennsylvania's Equity in Interscholastic Disclosure Law

Before my freshman year of college, I had never even swum in the ocean. Because of lacrosse, I have been able to travel all across the country and visit both oceans in the same season. My experiences from playing lacrosse in college have been amazing and have truly shaped my college experience. In my time playing lacrosse I have put in hard work, had many leadership opportunities, and had so much fun that I would not trade it for anything.

I am so grateful that lacrosse has granted me so many opportunities over the years, but I know that not all girls have the same chances that I did. After working extensively with athletics data during my internship with the Women's Law Project this summer, I learned that high schools, middle schools and junior highs in Pennsylvania are lacking so many athletic positions for girls it would often take the creation of three or four new girls' teams to give girls the same number of athletic opportunities that boys have. As lacrosse had such an impact on my own life, the huge number of girls who are denied the opportunity to be a part of a team is incredibly troubling.

In 2012, Pennsylvania passed the Equity in Interscholastic Athletics Disclosure law which requires all public high schools, middle schools, and junior highs across the state to report a range of data about school athletic programs. including the number of athletic positions offered to boys and girls. This data is supposed to be publicly available and accessible, and should allow parents, students and community members in Pennsylvania to see if their school districts are providing equal opportunities for each gender. If properly enforced, this law should make the athletic programs of schools more transparent and allow students and families to see when girls are not being granted equality in athletic programming. Having this type of legislation when I was in high school would have been crucial when, at times, I felt our school was treating girls' athletics unfairly.

The enforcement of this important bill has been appalling, however, and the publicly available data is by no means accessible. Put into spreadsheets with thousands of rows, most of which are empty, the data is nearly impossible to read or easily interpret. Without trying to pull relevant information out of large and hard to read spreadsheets and individually calculating each school's disparities, there is no clear way to determine whether or not a school is providing equal opportunities for boys and girls.

Additionally, the Department of Education failed to post the data from the 2013-14 school year in a timely manner, despite several requests from the Women's Law Project. After they were posted nearly nine months late, the data was presented in the same complicated and unreadable format as the previous year. And what data we were able to pull out and analyze after much effort shows a real problem: Pennsylvania is missing thousands of athletic positions for girls. Countless schools across the state have massive Title IX violations and are not being held accountable.

The passage of the Equity in Interscholastic Athletics Disclosure law was a huge win for women and girls in Pennsylvania. It created a tool that I wish I had in high school. Allowing residents of Pennsylvania to check on their schools to ensure that they are providing equal opportunities to boys and girls is a great step towards gender equality. And while Pennsylvania took an important step in passing the law, the state's failure to timely and effectively convey the reported data to the public is a disservice to the girls of Pennsylvania.

I have been incredibly lucky to be a part of so many great teams, and I believe everyone has the right to these same opportunities. Participation in sports can have such a positive influence on a person's life, and providing these opportunities to young girls is essential. Providing athletic opportunities to girls allows them to grow up with confidence and enjoy the fun of being a part of a team. It is vital for girls to be granted equal opportunities, and providing the proper tools to ensure athletic equality is essential to the wellbeing and future of young girls. •

School Sustainability Culture Program Information Session


