Chartiers Valley Building Project a Vanguard of Healthy and High-Performing Schools

Chartiers Valley School District (CVSD) recently broke ground on a new middle and high school complex that we hope will set a new standard for how school design and construction in the Commonwealth will take place. The

forthcoming facilities embrace a student-centered approach to education by accommodating diverse and personalized learning experiences in synergetic and flexible spaces, where the buildings can foster creativity and be models of health and sustainability. What sets this project apart is not the advanced mechanical systems or the unique layout of classrooms. It is the process that CVSD administration embarked on before the building design was even started. This process included several notable aspects:

- Setting high performance goals for student health, environmental impact, and effective learning that informed the selection of the design team;
- Establishing a set of <u>guiding principles</u> cocreated with the community, which help set priorities and make decisions throughout the process;

- Being patient, inclusive, and collaborative with the CV community, and allowing them to be truly central to the process, such as through the School Design Advisory Teams (SDAT);
- Taking the SDATs to visit numerous schools inside and outside the region to look at innovative practices and approaches;
- Using an integrative design approach which allows for continuous dialogue and feedback between students, staff, community members, designers, and builders leads to a building that best meets the demands of 21st century learning and high-performance school environments.

We are excited to see and experience the results of this bold and ambitious approach, and hope that all schools in our region have the opportunity to learn from CV's process. Innovative Learning Lab

How might we inspire and support educators and learners in adopting mindsets and behaviors based on holistic sustainability? How do we even define holistic sustainability? At the Green & Healthy Schools Academy, we live and breathe these questions. Our programming does not seek to provide an answer; instead, we design experiences that provide the time, space, and interactions that challenge the participants to live these questions with us. In this we hope that they begin to see sustainability as more than a recycling program or energy audit, as important as those are, but an exploration of community, justice, love, and beauty.

Our schools are not designed for this kind of dialogue. In many ways, our modern world is not designed for it. Engaging in this kind of sustainability is hard. As such we are excited to launch the Innovative Learning Lab to explore these questions further and experiment with different learning strategies. It is a place to take risks in program design and execution. It is a place to document and reflect on our process with as broad a community as possible.

Here is a snapshot of some ongoing activities in the Innovative Learning Lab:

- Data & Place: In partnership with CMU's CREATE Lab, we are designing a place-based learning program that explores the relationship between data and place. The program provides a space for educators and learners to investigate the most effective ways to use data in understanding a community and the impact of using data in this way. Scheduled for Spring 2017
- Systems Design Labs: We are creating a series of Systems Design Labs that will embed systems thinking within the human-centered design process, and determine effective ways to bring the growing field of systems change to K-12 educators and students. Starting Fall 2016

• Ethics in STEM: We are excited to begin a partnership with Intermediate Unit 1 that will explore how we might teach about ethics and impact while designing STEM-oriented lessons, units, and project-based learning. This is part of our desire to build the architecture for a larger conversation about purposeful maker education.

In Brief: School Law Update

What Act 10 Means for School Districts By Annemarie K. Harr, Esq.

Earlier this year, Act 10 of 2016, which permits local government agencies to invest public funds in certain types of financial products which previously not permitted, was signed into law.

Act 10 expands the types of

investments permitted for these agencies to include commercial paper, bankers' acceptance and negotiable certificates of deposit. These additional investments can allow school districts to more fully diversify their investments. However, with these new types of investments, school districts can also be faced with potential financial risks as their ability to invest expands.

Though the Act may have been intended to cover school districts, it is important to note that the Act did not amend portions of the School Code which relate to district investments and money management. Under Sections 621-623 of the School Code, in order for a school district to deposit funds, the deposit instrument must meet certain collateralization requirements. Currently, there are no known negotiable certificates of deposit that meet these requirements and therefore, if the amount of a negotiable certificate of deposit exceeds \$250,000 (the limit of FDIC deposit protection), any investment of district funds would be in direct violation of the School Code under 24 P.S. §§ 6-621-623. Additionally, the Act does not amend Section 440.1 of the School Code which covers the investment of school district funds. That section of the School Code does not include the types of investments outlined in Act 10. As such, there is an argument that because Act 10 does not amend the School Code, school districts are still held to the investment standards contained therein.

School districts or CTCs wishing to expand their investment options under Act 10 should do so in direct consultation with their solicitor to ensure compliance with all governing statutes.

Update: Anti-Hazing Law

On July 25, 2016, a new law took effect in Pennsylvania. Act 31 of 2016 amended the Anti-Hazing Law of 1986 to now cover secondary schools and their students in grades 7-12.

Originally, the Law only extended

to institutions of higher education; however, the amendments add a definition of secondary school to the Law. Under the Law, "any public or private school within this Commonwealth providing instruction in grades 7 through 12 or any combination of those grades" must now:

- 1. Adopt a written anti-hazing policy which includes rules prohibiting hazing;
- Provide a copy of its written anti-hazing policy, rules, penalties and program of enforcement to all athletic coaches at the school;
- **3.** Post its written anti-hazing policy on its publicly accessible website.

Hazing is defined under the Law as, "any action or situation which recklessly or intentionally endangers the mental or physical health or safety of a person or which willfully destroys

or removes public or private property for the initiation or admission into or affiliation with, or as a condition for continued membership in, any organization. The terms shall include, but not be limited to, any brutality of a physical nature, such as whipping, beating, branding, forced calisthenics, exposure to the elements, forced consumption of any food, liquor, drug or other substance, or any other forced physical activity which could adversely affect the physical health and safety of the individual, and shall include any activity which *continued on next page*

Anti-Hazing Law Update, continued

would subject the individual to extreme mental stress, such as sleep deprivation, forced exclusion from social contact, forced conduct which could result in extreme embarrassment, or any other forced activity which could adversely affect the mental health or dignity of the individual, or any willful destruction or removal of public or private property. For purposes of this definition, any activity as described in this definition upon which the initiation or admission into or affiliation with or continued membership in an organization is directly or indirectly conditioned shall be presumed to be "forced" activity, the willingness of an individual to participate such activity notwithstanding."

The Law requires that schools adopt procedures to enforce the rules against hazing and penalties for the violation of such rules. The Law specifically states that schools may, as a penalty, impose fines, withhold diplomas or transcripts or impose probation, suspension or expulsion upon students who violate the school's anti-hazing policy, and may even result to disbanding sports' teams or groups that operate on school property or under the sanction of the school. Furthermore, any penalties imposed by the school shall be in addition to criminal penalties that may be imposed on violators.

As the school year begins, it is necessary that school districts recognize their new responsibilities under the law. Please do not hesitate to contact WBK for questions regarding compliance with these requirements, including the revision of your current policies and student handbook to include this important update.
